## **TRIP CANCELLATION POLICIES**

- In the event of a Client cancellation occurring 0 to 90 days prior to arrival liquidated damages in the amount of ninety percent (90%) of the “Anticipated Room Night, Event, and Banquet Food and Beverage Revenue Figures” will be due, plus applicable taxes and service charges.
- In the event of a Client cancellation occurring 91 to 180 days prior to arrival liquidated damages in the amount of eighty percent (80%) of the “Anticipated Room Night, Event, and Banquet Food and Beverage Revenue Figures” will be due, plus applicable taxes and service charges.
- In the event of a Client cancellation occurring 181 to 365 days prior to arrival liquidated damages in the amount of seventy percent (70%) of the “Anticipated Room Night, Event, and Banquet Food and Beverage Revenue Figures” will be due, plus applicable taxes and service charges.
- In the event of a Client cancellation between the time of acceptance of this contract and 366 days prior to arrival liquidated damages in the amount of fifty percent (50%) of the “Anticipated Room Night, Event, and Banquet Food and Beverage Revenue Figures” will be due, plus applicable taxes and service charges.

\*Client is financially responsible for all guest meals who cancel after “Final Guarantees” date, and Sugarbush Resort reserves the right to enforce a 5% surcharge for any additional guest not included in the final count on this date.

## **FORCE MAJEURE CLAUSE**

- No damages shall be due for a failure of performance occurring due to Acts of God, War, Terrorist Act, Government Regulations, Riots, Disaster or Strikes, any one of which make performance impossible. Sugarbush Resort shall have no liability for power disruptions of any kind.
- If a Force Majeure Event limits but does not substantially eliminate the affected party’s ability to fulfill the booking(s) under this Agreement, the booking will proceed on a limited basis and the parties will work in good faith to modify the scope and cost of the booking accordingly. If a Force Majeure Event substantially eliminates the affected party’s ability to fulfill the booking(s) under this Agreement, including where the Hotel has decided to close to the public, the Hotel may postpone the booking(s), in which case the Group will receive a credit for all amounts paid and the parties will work in good faith to reschedule the booking(s). Should a reasonable number of alternative dates be available, and the Group does not reschedule, however, the Group will be required to pay the Hotel’s cancellation fee.
