## **TRIP CANCELLATION POLICIES**

**After Booking and up to 120 days (Oct 13, 2023) prior to departure cancellation policy is as follows:**

- Any and all cancellations are subject to a \$95.00 per person contracted administration fee up until 120 days prior to departure.
- Any and all cancellations received 119 to 95 days prior to departure - \$295 per person cancellation contacted fee.
- Any and all cancellations received 94 to 65 days prior to departure - \$595 per person contacted cancellation fee.
- Any and all cancellations received 64 days or less to departure – no refund.

No refunds for early departure or late arrival. No shows, no refund. No partial refunds will be made on car rentals, airfare, or any unused portions of this package.

All cancellations **must be in writing and sent to Alphorn Tours and Incentives, Inc., 1 Harris Street, Newburyport MA 01950.** Date postmarked will determine the applicable policy.

**Refunds will be made as soon as they are received from vendors (minimum eight (8) weeks).**

## **NAME CHANGES, SUBSTITUTIONS AND REPLACEMENTS**

Airline-related fees: Applicable to name changes, substitutions, cancellations after ticketing.

- Where possible, ATI will make name changes and substitution of passengers with only a \$100 reissue fee.
- Per ATI's contract with the various airlines involved, a fee of \$100 may apply to correct a name and \$250 to transfer ticket to a substitute passenger.
- Participants who cancel their trip after ticketing will have a non-refundable ticket.

## **FORCE MAJEURE CLAUSE**

- Either party may terminate or suspend its obligations under this agreement to the other party if such obligations are delayed, prevented, or rendered impractical by the occurrence of any of the events listed, including but not limited to: pandemic, fire, flood, earthquake, hurricane, civil commotion, insurrection, act of God, strikes, riot, government action, provided that the party which is unable to perform its obligations provides notice to the other party as promptly as possible following the onset of such events or circumstances. In the event that such force majeure affects the meeting, either party may cancel all outstanding portions of the meeting without incurring any charges. Alphorn Tours will in good-faith attempt to retrieve deposits paid to vendors, but cannot guarantee any cash refunds or airline and resort/hotel credits. Good faith does not include the requirement that Alphorn Tours bring lawsuits against said vendors in any jurisdiction. Alphorn Tours does hereby agree to assign any rights or claims against said vendors to the Group.

## **HOTEL ATTRITION POLICY**

- Should the entire group cancel after May 1, 2023, the \$2,000 Group Deposit is non-refundable.
- Should the entire group cancel after November 1, 2023 until 60 days prior to arrival – the First Night Room & Tax deposit is non-refundable.
- Individual Cancellations (up to 2 guest rooms) after the First Night Deposit is received and before the Full Payment is received will be accepted without penalty. The First Night Deposit would get rolled over and applied toward the full balance.

## **INSURANCE**

We strongly recommend the purchase of trip insurance covering, accident, sickness or death of a participant or covered family member that would result in cancellation either prior to or during the trip. We have insurance information for your Group.
